The Public Hearing is scheduled for Monday, August 21, 2023 and Tuesday, August 22, 2023. The hearing will begin at 10:00 a.m. and will end no later than 5:00 p.m. each day.

The witness list and exhibit list shall be provided to each party no later than noon, Thursday, August 17, 2023. All exhibits should be labeled by the parties in the manner discussed. Any objections to exhibits shall be made prior to the hearing. All parties shall provide any outstanding documents no later than August 17, 2023.

The Order of the Hearing shall proceed as follows:

Blue Cross Blue Shield shall present their opening statement and proceed with the Presentation of their case.

Elevance shall then present its opening statement and proceed with the Presentation of their case,

Public Comment shall follow the Presentation of Elevance's case.

The Department of Insurance will then make its presentation.

After the close of the presentation by the Department of Insurance, each party will be allowed to make a closing statement in the following order:


