This is to express opposition to the acquisition of Blue Cross and the Plan of Reorganization to facilitate that acquisition. I am currently a policy holder as is my wife. I received a huge bundle of documents that indicated Blue Cross wanted to reorganize to facilitate an acquisition by another company. It promised large pay-outs to the shareholders. I later received a flyer indicating that my PIN needed to voice my opinion directly to Blue Cross was in that large stack of document, which I then saw no point in retaining.

I cannot see how a company can acquire Blue Cross for a large sum of money and rely on the current stream of income to pay for that acquisition. It is my belief that changes will be necessary to cover the cost of that acquisition including the reduction of benefits and or the raising of rates. The reclassification of Blue Cross should not be considered independent of its ultimate goal, to sell the company to a non-Blue entity. This cannot financially benefit the policyholders and will result in loss of value in the form of increased premiums or the reduction of benefits.
